The package listed above is based on prepayment. The minimum requirements for the Sport Pilot are 20 hours of Total Time with 15 hours of Dual, 5 hours of Solo with 2 hours of Cross Country time (at least 75 miles) and 10 take-offs and landings. Our package includes an additional 7 hours: 2 solo and 5 dual to insure safety requirements are met. When the package is purchased \$440.90 will be added to your account in the form of a credit, to use as you desire.
